Crime Reports-2018

During the 2018 calendar year, our officers logged a total of 3212 incidents. An incident is defined as any actions taken by our officers. These can be self-generated, such as traffic stops or property/area checks, or calls for service from members of the community. Of the 3212 incidents, 264 were of a criminal nature, initially classified as follows:

Achievements

- Fredonia's University Police
 Department achieved reaccreditation in 2018, considered the "gold standard" of professional law enforcement. Only 25% of New York State law enforcement agencies are accredited.
- UPD continued its rigorous programming to educate students and staff in emergency procedures.
- UPD continued to provide Fredonia State excellent emergency response to bomb threats, medical emergencies, and potentially life threatening situations.
- UPD enhanced partnerships and collaboration with federal, state, and local law enforcement agencies.
- UPD hosted practical training events to keep students safe on and off campus.
- UPD maintained close collaboration with local fire, EMS, and mental health care providers.

Traffic Offenses:

Traffic and parking enforcement is and has been a priority function of the University Police Department. This is not only from a safety point of view for the students, faculty, staff, and visitors to our campus, but also to ensure the prime mission of education by the University is carried out without interruption or undue interference.

Our campus setting lends itself to a considerable amount of vehicular traffic each day, and is also a convenient "shortcut" for the surrounding residents. This high-density area is also restricted by physical limitations on the number of parking lots and spaces available.

While traffic violations are not considered as serious as Part I and Part II Crimes, the safety implications of good traffic control and the volume of traffic offenses on campus require close attention.
