Rockefeller Arts Center comprises a 1200-seat concert hall, a 400-seat proscenium theatre, a 200-seat experimental theatre, two art galleries and numerous studios, shops and offices. Over 170 events are presented annually by the center and 22 academic departments, student groups and community organizations.

Responsibilities include artistic direction; facility management; marketing and public relations; budgeting and financial management; fund raising and income development; developing and coordinating user services; producing, negotiating and contracting arts events; short-term and long-term planning; hiring and supervising staff; policy formulation; and directing an undergraduate degree program in arts administration.

Wrote comprehensive mission statement and statement of operating philosophy for the center and developed its first written five year plan. Revised policy manual and established written procedure manuals for all areas of center's daily operations.

Established program of support services to academic departments and other facility users including marketing research, interest-coded mailing list, centralized usher corps, combined subscription campaigns, comprehensive semi-annual event calendars, coordinated solicitation of corporate sponsors and publication of event playbills.

Originated four popular series designed to complement offerings of academic departments. Targeted at specific market segments, these series include "On Stage for Youth" (daytime performances for area school groups), "Kaleidoscope" (early evening shows for parents and children), "World Travel" (travel-adventure film lectures for general public and senior citizens), and the "DFT Communications Pops" (light classics, jazz and show tunes for traditional music lovers.)

Established a program of annual financial support from area foundations, business and individuals. This program, which included starting a community support group called "Friends of the Michael C. Rockefeller Arts Center," has raised over \$1.5 million since its inception. Also set up center's first major gift and endowment program.

Took over oversight of the University wide ticket office in 2007; installed new campuswide computerized ticketing system, hired new manager and established new procedures, greatly increasing customer service and financial accountability.

Coordinated and/or participated in over \$6 million worth of improvements to physical plant including upgrading of theatrical lighting/dimming systems, repair/replacement of stage rigging and curtains, addition of studio and shop ventilation, building-wide asbestos abatement and window replacement, renovation of art gallery, ADA compliance projects, and interior decoration of public spaces.

Provided academic advising, experiential learning opportunities, mentoring and career guidance to scores of students, many of who have gone on to successful careers in arts management throughout the country.

Also provided advice and counsel to supervisors of employees with problematic behavior and ensured compliance with due process rules when termination was necessary.

CREATIVE ACHIEVEMENTS at SUNY FREDONIA Since 1992, I have served as producer of the pops concerts by the Western New York Chamber Orchestra (WNYCO), a regional professional orchestra which is an ensemble-in-residence at the School of Music. Most frequently done the night before the annual campus commencement ceremonies, the concerts showcase student vocalists. My role has included collaborative conceptual and thematic planning of each concert, selection of repertoire and guest artists, and hiring and coordinating members of the creative team (conductor, staging consultant, rehearsal coach, and designers for wardrobe, set dressing and lighting). I also serve as emcee for these events, which has allowed me to establish a strong personal bond with local audiences.

Starting in 2003, I started doing some of our commencement-eve concerts with a 17-piece big band made up of top regional jazz players instead of orchestra. In the fall of 2012, I took the concept of the Commencement-Eve Big Band concerts and transplanted it to December, creating a large production entitled The Big Band Christmas Spectacular. The program, with a cast of 10 and a crew of 8, featured vocal solos, duets; and quartets; dance numbers, instrumental selections, elaborate stage décor and special effects. The concert culminated six years of planning and included many musical arrangements created especially for the event. It was the first complete sell-out in the history of the pops series and generated a resounding and enthusiastic audience response. We are now planning to mount a similar concert in December of 2014 and hopefully every even-numbered year thereafter.

Produced "The Ring of the Fettuccines," a humorous and engaging hour-long introduction to opera for young people with melodies "borrowed" from 17 famous and not-so-famous dead composers. This was a collaborative effort with faculty members from the School of Music and students chosen by audition (December 2000). Also done during spring semester 2004, including an outreach spring break tour to three upstate New York cities.

## PREVIOUS ARTS MANAGEMENT EXPERIENCE

In Midland, Michigan, (1979-82) served as the chief executive of a community theatre division (one of six member groups) of a multi-million dollar community arts center.

Responsibilities included supervising staff, audience development, fund raising, budgeting and bookkeeping, planning and implementing appearances by touring artists and companies. Expanded number of productions from 9 to 17 per year , including emphasis on booked-in as well as locally produced productions; initiated annual series of professional artist residencies for area school children; increased annual giving by 148% and subscription base by 37%.

At Michigan State University, (1976-78), served on the staff of one of the largest University-based presenters in the Midwest. Provided audience development and marketing support for 60 events annually with major responsibilities for mailing list maintenance and computerization. Assisted University development office with prospect identification for \$17 million fund raising campaign for new performing arts center. Also had complete charge of Director's Choice Film Series including booking, operations and marketing; increased film series attendance 76% in one year.
