#### Advancement Check Sheet

All second semester Sophomores and transfer students with 57 or more credit hours wishing to continue in the social work major must successfully complete the advancement process. Students will not be allowed into the practice methods courses (SOCW 325 and beyond) unless they are approved through this process. An application with supporting documents must be filed **by the last Friday of April** for first consideration. The following check sheet is meant to assist you in completing the application. NOTE: Students admitted to the program are required to satisfactorily complete a 450 hour field placement in their senior year. For placement into a practicum, agencies require personal information and conduct background checks. Agencies have the right to refuse placement. Agencies may deny placement for people with felony convictions, some misdemeanor convictions, or abuse and neglect charges. The Fredonia Social Work program will work diligently to place students, but students admitted into the program are not guaranteed placement into an agency. Additionally, students with a concern about their background issues should be aware that some other states require licensure for a BSW practitioner and states require licensure should a student pursue an MSW. Some states restrict or deny licensure for the above reasons. Students having such a situation might benefit from consulting with their state's social work licensing board before pursuing a social work degree.

# The State University of New York at Fredonia Social Work Program F.A.Q. of Interest to Advancement Applicants

#### 1. What social work degree does Fredonia offer?

Fredonia's social work program is a baccalaureate degree program (generically referred to as a BSW program). At graduation, Fredonia students receive a Bachelor of Science degree (B.S.). This is the degree designated by SUNY for social work majors. This degree was authorized when the New York State Education Department approved the major in 1997. The social work program is accredited by the Council on Social Work Education (CSWE).

#### 2. What does accreditation mean?

Accreditation is the means by which many professions maintain quality education in their fields of study. Standards are developed by professional educators and programs are evaluated in terms of these standards. Accreditation by the Council on Social Work Education (CSWE) means that the curriculum and program meet the minimum standards created by the profession for social work education. The standards maintain the quality and relevancy of social work education. For Fredonia CSWE accreditation says to others that the Fredonia social work program has met these standards, and our educational experiences are equivalent to other accredited BSW programs.

There are other benefits to accreditation. Many states require licensure for social workers and some of these require their licensees to be graduates of accredited programs. Many Master of Social Work (MSW) degree programs offer a select group of graduates from accredited BSW programs the ability to proceed faster in their master's education programs through a course of study often referred to as Advanced Standing.

### 3. What do I have to do to earn a B.S. in Social Work degree from Fredonia?

You must (a) complete the general education program; (b) complete prerequisite social work courses; (c) successfully complete the Advancement process; (d) complete required social work courses; (e) complete 6 credit hours of approved diversity course work within the general education requirements; (f) maintain and complete a portfolio; (g) complete enough general elective hours and/or a minor to earn 120 credit hours; and (h) consistently demonstrate professional social work behavior (based on the National Association of Social Workers Code of Ethics).

**Please note:** No academic credit for life or work experience will be given as an equivalent for any required social work course or Introduction to Social Work.

#### 5. What is Advancement?

All sophomores and transfer students who seek to enter the Junior year Foundation Methods courses must apply for advancement in the Sophomore year. The process begins in the Spring semester when application forms are made available. The process ends prior to the beginning of the Fall semester when all pre-requisites have been met.

#### Criteria for Advancement:

- 1. Student must be a Sophomore who will have Junior standing at the beginning of the Fall semester (57 credit hours completed).
- 2. Student must file a completed application by the deadline date.
- 3. Student must submit a typed response to questions posed on the application.
- 4. Student must have a 2.5 average for the prerequisite course work.
- 5. Student must have a grade of "C" or better in SOC 218: Introduction to Social Work or its transfer equivalent
- 6. Student must have a cumulative grade point average of 2.0 or higher.
- 7. Three (3) letters of recommendation must be filed.
- 8. Transfer students must provide a transcript of previous course work when making application.
- 9. Student has demonstrated behavior, qualities, and characteristics expected of a professional social worker.

*Note:* The social work faculty reserves the right to require an interview with an applicant prior to making an advancement decision.

# 6. Do I get to do an internship in this major?

Yes, but we don't call it an internship because it is much more intense. As a senior, you will enroll in Field Practicum courses each semester. A practicum is an education experience in which you begin to practice social work under the supervision of a professional social worker. Our Field Practicum is one singular experience spread out over two semesters totaling 450 hours of activities in the same agency. Students are expected to complete 225 hours in the same agency in both the Fall and Spring semesters while concurrently taking other required and elective course work. Field Practicum courses are listed in the catalog as SOCW 480, 485, 490 and 495. Field practicum students are expected to engage in practice with systems of all sizes: individuals, families, groups, organizations, and communities.

# 7. In the College Catalog it says that social work students must stay "in sequence", what does that mean?

After successfully passing Advancement into the Junior foundation practice courses, students must take the foundation practice courses in the order presented. This is because the Fredonia social work curriculum is developmental in nature. Each course builds on the material learned in the course that comes before it. See the back of this sheet for the basic curriculum sequencing of our program.

#### 8. Can I transfer or enroll in the Spring?

Because the foundation practice courses are sequenced, the social work program is considered a "Fall Admission Only" program. In reality, students can transfer or enroll in the Spring semester but their course selection is limited to general education and general elective choices and their matriculation at Fredonia will extend past 4 full time semesters. If this situation applies to you, check with your advisor or the Social Work Program Director to explore your options.

#### 9. What are the expectations for professional conduct?

Social work is also a professional field with expectations of professional behavior. Students who meet the published criteria but who have evidenced a pattern of unprofessional, unsuitable behavior may be denied advancement and/or dismissed from the program. Students may also be dismissed from the program for academic reasons. Students must earn a grade of "C" or better in their required social work foundation courses to continue in the major. More specific expectations and policies are detailed in the student handbook.

Admission to the Social Work major and Advancement is based upon the published criteria. Race, color, religion, creed, gender, ethnic or national origin, disability, age, political orientation, veteran status, or sexual orientation play no role in the admission's decision.
